Please note the requirements: When starting a new business as a sole trader you must not be in bankruptcy, be prohibited from carrying on business or have a custodian pursuant to the Parental Code.

Under the age of 18

If you are 16 or above, but under the age of 18, you may be a sole trader if your guardians and the Chief Guardian of the municipality give their permission. The permission of the guardians and the Chief Guardian must be included in the application form or enclosed as an attachment.

Resident abroad

If the new owner does not have a Swedish personal identity number you must instead fill in a coordination number (samordningsnummer). Skatteverket (the tax authority) issues the coordination number. Send in a copy of the decision from Skatteverket. You must also submit a certified copy of the passport or other identification document, if he/she is not registered in the Swedish population register. Furthermore, you need to report a manager for registration in Sweden if you are resident outside the EEA. Use form no. 943/943 e Manager – Sole trader.

4. The new address of the enterprise

If the address of the enterprise and the owner's address are identical, write the owner's name stating c/o in the field of the postal address of the enterprise to ensure that documents from us will reach the enterprise.
